

## **ABOUT THE ENDOWMENT**



The Bangor Symphony Orchestra's mission is to provide powerful, enriching, and diverse musical experiences through live concert performances and education programs of the highest quality. The Endowment Fund ensures this critical mission will be fulfilled for future generations and through periods of great unpredictability.

The BSO's Endowment is comprised of a general fund, the draw of which offsets critical artistic and operational expenses each year, as well as restricted purpose funds, established by donors to underwrite individual musician chairs and specific educational programs, such as the Bangor Symphony Youth Orchestras. Ticket sales only cover 40% of annual expenses, with the Endowment Fund playing a vital role as we seek to keep ticket prices affordable while growing for the future.



#### HOW YOUR GIFT WORKS:


- 1. A donor makes a gift to the General Endowment Fund, which supports all aspects of the BSO's artistic and educational programming. (*Please talk to us if interested in a restricted purpose or named gift*).
- The Investment Committee prudently invests the donor's gift across major asset classes in the BSO's portfolio to maximize long-term total return and manage risk.
- 3. A predetermined portion of the annual return\* is used for the intended purpose. The Fund's principal remains intact.
- 4. The remainder of the annual return is reinvested along with the Fund's principal as a hedge against inflation and to generate growth.
- 5. The Fund continues to grow, ensuring future support.


#### **CELEBRATING A FELLOW MUSICIAN**

Bob Nicholson joined the Bangor Symphony Orchestra bass section in 1994 and was a self-proclaimed "latecomer" to orchestral playing. It was former Principal Bassist Robert Rohe, who passed away in 2013, that took a chance on him. Nicholson says, "I immediately liked and respected Bob, for his long experience and for his kindly manner. He'd regale us with tales such as rowing across from his island home to the mainland in stormy winter weather, bass tucked on board, to concert engagements. I played my very best, knowing he'd subtly support me in my part. It was hard for us to see him retire,



and I wanted to do something to preserve his memory in some way, as he had helped the orchestra in his." Bob and his wife Gloria utilized the IRA charitable rollover, also known as the qualified charitable distribution, to create an endowed fund supporting the principal bass chair in honor of Robert Rohe. As Bob says, "Long may it, and the BSO, prosper!"

Tom and Hope Gower were long admirers of the Bangor Symphony Orchestra. After Tom joined the Board of Directors, their appreciation only grew. As a senior vice president of wealth management at UBS Argosy Wealth Management, Tom appreciated the importance of an endowment campaign for sustaining the organization into the future. He and Hope were early lead donors to the 125th Anniversary Endowment Campaign, and have this to say about their support:
